Americanism Remembering the Spirit of 1620

In observance of our country's Thanksgiving Day holiday, *The Wall Street Journal*, in 1961, began annually printing excerpts from "The Desolate Wilderness", an early chronicle of what the Pilgrims endured in 1620, as they endeavored to establish a new colony in America. The events were recorded by Nathaniel Morton, and were based on the accounts of his uncle, William Bradford, the governor of Plymouth Colony for all but a few years from 1621 – 1657. The following excerpts from "The Desolate Wilderness" can offer some perspective on the difficulties and uncertainties the Pilgrims faced, and the sustaining strength they gained from their strong religious faith:

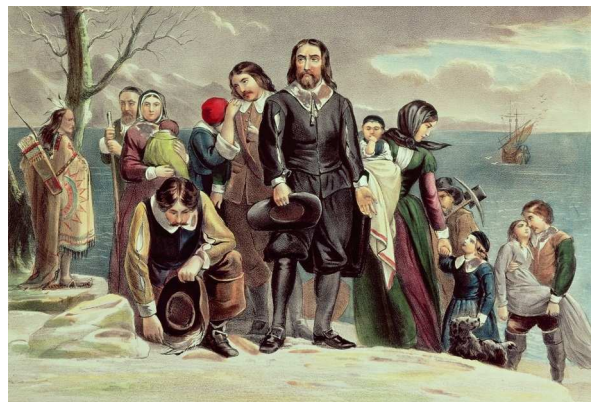
When they came to Delfs-Haven they found the ship and all things ready...The next day they went on board...Their Reverend Pastor, falling down on his knees, and they all with him...commended them with the most fervent prayers unto the Lord and His blessing...

Being now past the vast ocean, and a sea of troubles before them in expectations, they had now no friends to welcome them, no inns to entertain or refresh them, no houses, or much less towns, to repair unto to seek for succour; and for the season it was winter, and they that know the winters of the country know them to be sharp and violent, subject to cruel and fierce storms, dangerous to travel to known places, much more to search unknown coasts. Besides, what could they see but a hideous and desolate wilderness...for which way soever they turned their eyes (save upward to Heaven) they could have but little solace or content in respect of any outward object; for summer being ended, all things stand in appearance with a weatherbeaten face, and the whole country, full of woods and thickets, represented a wild and savage hew. If they looked behind them, there was a mighty ocean which they had passed, and was now as a main bar or gulph to separate them from all civil parts of the world...What could now sustain them but the spirit of God and His grace?

Nathaniel Morton was 10 years of age when he and his father arrived at Plymouth Colony from England in 1623. In 1645, Morton became the annually elected Secretary of Plymouth Colony, a position he held until his death in 1685. Having carefully maintained the colony's records, he compiled them into a book, *The New England's Memorial*, published in 1669. In it, he borrowed from his uncle's chronology of the development of the colony, William Bradford's *Of Plymouth Plantation*, and combined it with his own accounts. It has been considered the 1st comprehensive history of Plymouth Colony.

Morton sought to acknowledge God's providence in the establishment of the colony. In his introduction to *The New England's Memorial* he stated, "...the main ends of publishing this small history, is, that God may have His due praise...and the present and future ages may have the fruit and benefit of God's great work in the relation of the first planting of New-England." He hoped the book would be used "as a remembrance of the Lord's goodness, to engage to true thankfulness and obedience; so it may be a help to thee in thy journey through the wilderness of this world..."

As we celebrate Thanksgiving Day this year, may we also remember and engage in true thankfulness for the blessings America has received.

American Diabetes Month

Diabetes affects nearly 30 million children and adults in the United States.

An estimated 86 million Americans have prediabetes and are at risk for developing type 2 Diabetes.

Diabetes almost doubles the risk for heart attack and for death from heart disease. It is the leading cause of kidney failure.

Diabetes is the leading cause of new cases of blindness among working-age adults.

60 to 70 percent of people with Diabetes have mild to severe forms of nerve damage that could result in pain in the feet or hands, slowed digestion, sexual dysfunction, and other nerve problems.

7th leading cause of death in the United States.

Symptoms:

Urinating often

Feeling very thirsty or hungry even when eating

Slow to heal wounds

Weight loss- even when eating more (Type 1 Diabetes)

Tingling, pain, or numbness in the hands/feet (Type 2 Diabetes)

Cost of Diabetes:

Prevention:

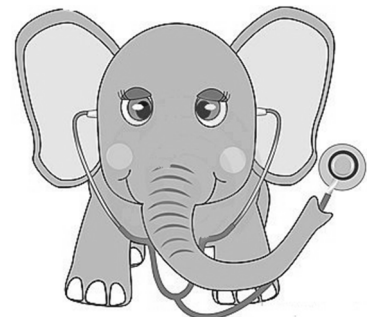

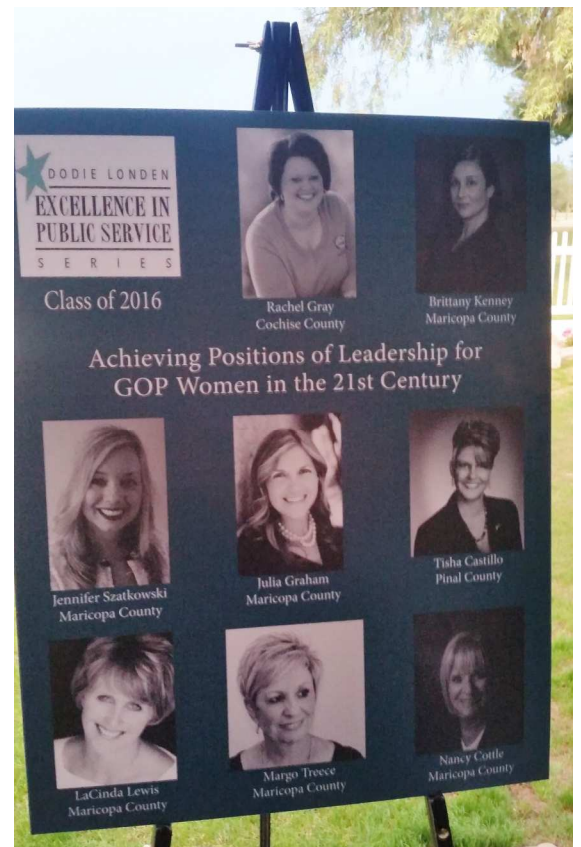

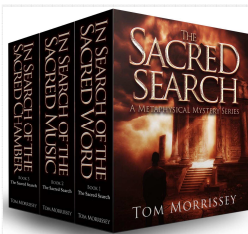
